## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is made and entered into as of 15th January 2025 by and between:

Hereinafter referred to as "NACC", and

**DrashtiNetralaya**

**Ukardi Road**

Hereinafter referred to as "Drashti Netralaya".

### Recitals

WHEREAS, Navjivan College is committed to the overall well-being of its students, including their physical health;

WHEREAS, DrashtiNetralaya is a non-profit organization dedicated to providing quality eye care services to the community;

WHEREAS, both parties recognize the mutual benefits of collaborating on eye health initiatives for Navjivan College students;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

### 1. Purpose of the MOU

The purpose of this MOU is to establish a collaborative partnership between NACC and Drashti Netralaya to conduct eye check-up for the Navjivan College students.

NACC will get eyes checked of all its students and Drishti Netralay with its modern technology and expert doctors will check all the students for free.

If the students have problems with the eyes Drishti Netralay will suggest them measures and treatments that will be chargeable and students are free to take them from any other hospital if they like.

Students of NACC can work as volunteers with Drishti Netralay and get some exposure.

Drishti Netralay is also ready to provide internship to selected students after rigorous interview.

NACC agrees that if there are interested students they can take courses offered by Drishti Netralay.

## 2. Responsibilities of Drashti Netralaya

- at DM
- Eye Check-up Camps: Drashti Netralaya shall organize and conduct eye check-up camps at Drishti Netralay & NACC campus or at a mutually agreed-upon location.
  - Medical Personnel: Drashti Netralaya shall provide qualified medical personnel, including ophthalmologists and optometrists, to conduct the eye check-ups.
  - Equipment and Supplies: Drashti Netralaya shall provide necessary equipment and supplies for the eye check-ups.
  - Post-Check-up Services: Drashti Netralaya shall provide follow-up services, such as referrals to specialized eye care providers, as needed.

## 3. Responsibilities of NACC

- Student Participation: NACC shall encourage its students to participate in the eye check-up camps.
- Volunteer Support: NACC shall provide volunteers to assist Drashti Netralaya during the eye check-up camps, as needed.
- Facilities and Logistics: NACC shall provide necessary facilities, such as classrooms or other suitable spaces, for conducting the eye check-up camps. If needed students will be checked at Drishti Netralay.
- NACC will encourage its students to take courses of their choice at Drishti Netralaya

## 4. Confidentiality

Both parties agree to maintain the confidentiality of any information shared during the course of this MOU.


## 5. Term and Termination

This MOU shall be effective from the date of signature and shall continue in full force and effect for a period of 5 years, unless terminated earlier by mutual written consent of both parties.

## 6. Amendment

Any amendment to this MOU shall be in writing and signed by authorized representatives of both parties.

The camps will be conducted at DM. It was agreed upon that 50-100 students a/day can be tested for problems at DM and at the same time they visit DM also.
