





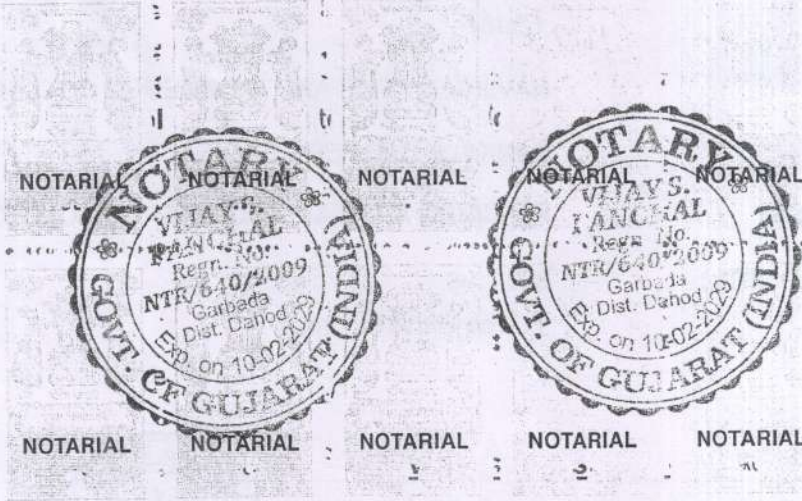

Whereas :

- (3) Second party have to provide Books to the Students for the competitive exam.








